JUDGE STAYS FDA APPROVAL OF ABORTION PILL

A federal judge in Texas issued a much-anticipated ruling Friday that stayed the Federal Drug Administration's (FDA) approval of the leading abortion drug mifepristone in 2000. Almost immediately after that decision, a judge in Washington state issued a ruling that the FDA should continue to allow mifepristone to be prescribed, setting up a possible showdown in the U.S. Supreme Court.

FBI ADMITS INFILTRATING MORE CATHOLIC CHURCHES

The FBI used at least one undercover agent to develop plans to cultivate "sources" in Catholic churches, according to internal documents obtained by the House Subcommittee on the Weaponization of the Federal Government. The FBI has sought to use Catholic churches as "new avenues for tripwire and source development," including at "mainline Catholic parishes" and among "local diocesan leadership," the documents revealed.

14 States That Ban So-Called 'Gender-Affirming Care' for Minors

In early March 2023, CatholicVote reported on seven states that had banned so-called "gender-affirming care" for children under the age of 18. They are: Mississippi, Tennessee, South Dakota, Utah, Alabama, Arizona, and Arkansas.

New York Legislature Passes Bill Forcing Universities to Give Students Dangerous Abortion Pills

State Assembly Bill 1395C requires State University of New York (SUNY) and City University of New York (CUNY) campuses to provide abortion drugs to students. The schools must employ or contract with individuals authorized to prescribe abortion drugs on campus or provide abortion referrals to students off campus.

"TRANS" ACTIVISTS SHUT DOWN PRO-LIFE EVENT

Violent "transgender" activists and Antifa agitators interrupted a Students for Life event titled "Lies Pro-Choicers Believe" at Virginia Commonwealth University last week.

Police arrested activists, but also forced the pro-life speakers to leave. A Students for Life spokesperson said the organization was "deeply disappointed" with how law enforcement handled the incident, adding: "Pro-life speech is free speech and should have been firmly defended as such, especially at a public university."

Here are Pharmacies That Don't Sell Abortion Drugs Killing Unborn Babies



In January the FDA changed its rules to allow chemical abortion pills such as Mifepristone to be sold in major brick-and-mortar pharmacies. So far, CVS, Walgreens and Rite-Aid – three of the top five largest pharmacy chains in the United States – have taken steps to provide abortion-inducing drugs in their stores.

Here is a list of major pharmacy chains that, as of April 1, 2023, **do not offer Mifepristone** or other abortion-inducing drugs: **Costco and Walmart.**

Infamous Pink Abortion Clinic That Prompted Supreme Court to Overturn Roe Closes Down



The infamous abortion facility at the center of the case that overturned Roe v. Wade is no longer in business. Nicknamed the "Pink House" because of its bright pink exterior, the Jackson Women's Health Organization (the Jackson in Dobbs v. Jackson) aborted unborn babies for many years and was the only abortion facility in Mississippi after 2004.

Now, Mississippi protects unborn babies by banning abortions, and the "Pink House" is no more.

The building has been repainted white and soon will house a consignment store.

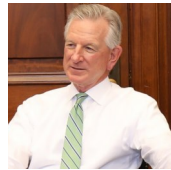
COLORADO DOCTOR PRESCRIBES SUICIDE FOR EATING DISORDER

Jennifer Gaudiani, a Colorado doctor and eating disorder specialist, has made public in a medical paper that she has been directly involved in steering patients with eating disorders such as anorexia toward assisted suicide. Colorado law does not allow assisted suicide for mental health conditions. Gaudiani argued that her intervention was nonetheless legitimate, since all three now-deceased patients she was involved with lived in states where assisted suicide under such conditions is legal.

According to a lengthy investigation recently published by the Colorado Sun, Gaudiani's paper was published in the February edition of the Journal of Eating Disorders. The paper explains why Gaudiani made the controversial decision to get involved in euthanizing three patients who suffered from what she described as "extreme cases" of anorexia nervosa. The Department of Health and Human Services (HHS) issued a "notice of proposed rulemaking" that seeks to redefine the terms "person," "natural person," and "individual" to exclude the unborn. The rule change proposal couches the move in language found in the Born-Alive Infants Protection Act of 2002, a pro-life federal law meant to protect babies who survive botched abortions.

Boston Archdiocese Responds to Satanic Temple's Convention



The Archdiocese of Boston is responding to the Satanic Temple's "SatanCon" event in Boston with scheduled eucharistic adoration, Catholic devotions, and "intense prayer."

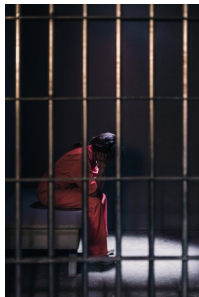

FEMALE INMATES TERRIFIED OF 'TRANS' BUNKMATES

"Anyone who transferred into women's correctional facilities by way of SB 132 — California's law that permits men to transfer into women's prisons by merely claiming to be women under the banner of having a 'gender identity' other than their sex — can request bed moves whenever and to wherever they want," writes Amie Ichikawa. None of the female inmates she knows were prepared for the influx of menacing, burly male bunkmates. "This is psychological warfare."

Thus far, the state review board cannot deny any request based on one's physical anatomy, criminal history, or sexual orientation. Contrary to what many might assume, these male prisoners are not required to have taken cross-sex hormones nor is it a requirement that they undergo a cosmetic surgery to remove their genitals.
